

POWERED PLEASURE CRAFT DRIVING LICENCE (PPCDL) COURSE 2024

PPCDL is required for operators of engine-powered/ jet-propelled pleasure craft (with SZ or SZH licence prefix) within Singapore Port limit.

PPCDL ensures that boaters are equipped with the necessary skills and knowledge to navigate their craft safely within the port waters. The PPCDL also allows relevant enforcement agencies to easily identify the operator.

Requirements

- 1) Be at least 16 years of age & physically fit
- 2) No colour blindness
- 3) No physical handicap

Participants are required to undergo regular medical checks, including eyesight checks to certify their fitness to drive (at own cost)
